A RESOLUTION ESTABLISHING 1974 SALARIES AND OTHER BENEFITS FOR CERTAIN ENUMERATED SALARIED EMPLOYEES

BE IT RESOLVED by the Neenah-Menasha Sewerage Commission as follows:

Section 1. SALARIES: The salaries of the following Commission employees positions are hereby established for the calendar year 1974:

Assistant Superintendent	12,550

Secretary	7,086

As used throughout this resolution, the term "salaried employees" shall mean the above designated positions.

Section 2. <u>WISCONSIN RETIREMENT ANDLIFE INSURANCE</u>: The Commission shall pay the full cost of both the employeer and employee contributions to the Wisconsin Retirement Fund and the full cost of the life insurance policy premiums as available to each of the salaried employees under the present Life Insurance Program.

Section 3. HEALTH INSURANCE: The Commission shall pay 95% of the premium cost for the salaried employees and their dependents for hospital and surgical coverage, the remaining 5% to be paid by the salaried employee and deducted from each salary check as required.

Section 4. <u>VACATION</u>: All salaried employees who have completed one (1) year of service shall be entitled to vacation as shown below:

One (1) year or more of service	5 days of paid vacation
Two (2) years or more of service	10 days of paid vacation
Eight (8) years or more of service	15 days of paid vacation
Fifteen (15) years of service	20 days of paid vacation
Sixteen (16) years of service	21 days of paid vacation
Seventeen (17) years of service	22 days of paid vacation
Eighteen (18) years of service	23 days of paid vacation
Nineteen (19) years of service	24 days of paid vacation
Twenty (20) years or more of service	25 days of paid vacation

All salaried employees shall be paid the equivalent of one (1) week of their salary for each 5 days of vacation to which they are entitled. A salaried employee will become entitled to his first week of vacation upon completing his first twelve (12) months of employment. The first week of vacation to which the salaried employee is entitled shall be following the first anniversary date of hire, and the succeeding December 31st. Thereafter, salaried employees may schedule weeks of vacation for which they are eligible anytime during the calendar year, subject to Manager approval, except that in any year in which they become eligible for additional weeks of vacation based on the length of service formula outlined above, the anniversary date of hire must expire prior to taking that additional week of vacation in that calendar year. Unused vacation may not be carried over from one calendar year to the next calendar year and any unused vacation rights shall be forfeited, except that any salaried employee off from work due to a job-connected injury or illness who has not used his vacation entitlement may extend his vacation rights into the following year. In individual cases where both the salaried employee involved and the Plant Manager specifically approve of the arrangement as being in the best interest of the salaried employee, salaried employees may be paid vacation pay in lieu of time off for any weaks of vacation beyond the first two for which the salaried employee is eligible in any calendar year.

Section 5. LONGEVITY PAY: The salaried employees whall receive, in addition to their regular salaries, longevity pay based on their length of continuous employment with the Commission in accordance with the following formula:

Years of Continuous Employment	Longevity Pay Per Month
5 years to 19 years	\$ 5.00
10 years to 15 years	10.00
15 years to 20 years	15.00
20 years or more	20.00

Section 6. HOLIDAY VACATION: Except for emergency plant operation, salaried employees shall not be required to work on the following holidays: Easter Sunday, Memorial Day, Independence Day, Iabor Day, Thanksgiving, the day before Christmas, Christmas Day, the day before New Year's Day and New Year's Day. (Nine days total)

If a holiday shall fall within the period of any vacation period, an additional day of pay or an additional day of paid vacation shall be given.

Section 7. SICK LEAVE: The Commission shall determine the length of the paid sick leave for sickness or injury not covered by the Workmen's Compensation Act of the State of Wisconsin in accordance with the salaried employee's length of service with the Commission.

Section 8. <u>FUNERAL LEAVE</u>: After one (1) year of continuous service the salaried employee shall be entitled to a maximum of three (3) days absence due to the death of a member of the salaried employee's immediate family. The salaried employee shall be compensated for the funeral leave on the basis of a pro-rata share of his regular salary.

Immediate family shall be defined as follows: Spouse, parents, children, brother or sister, natural mother or father of the employee's spouse.

A RESOLUTION ESTABLISHING SICK LEAVE POLICY

WHEREAS, the Neenah-Menasha Sewerage Commission has the authority by law to establish sick leave policy for its employees,

WHEREAS, the Neenah-Menasha Sewerage Commission desires to formalize its sick leave policy in writing.

BE IT THEREFORE RESOLVED AS FOLLOWS:

To be eligible for paid sick leave, an employee of the Commission must have satisfactorily completed his probationary period, and must be a regular employee. After a regular employee completes one year of continuous service, including probationary period, the employes shall accumulate paid sick leave benefits at the rate of one full day per each completed full month of service up to a total maximum accumulation of 120 days paid sick leave. No fractional days shall be earned for fractional months of service. Paid sick leave shall be at the rate of 100% of the employees wage rate as stated in the wage rate schedule included in the Union Agreement.

(cont...)

The accumulation of sick leave shall be retroactive for 5 years prior to December 31, 1973. Each employee's accumulation of paid sick leave to December 31, 1973 shall be computed by subtracting the number of sick leave days taken off in 1973, 1972, 1971, 1970, and 1969 from 60 sick leave days. The 60 sick leave days are computed by multiplying 12 days per year by 5 years retroactivity. All sick leave accumulated or used after January 1, 1974 shall be computed as described by this policy i.e. I full day accumulated for each full calendar month of service, minus sick leave days taken as of the effective date of this policy.

No employee shall be entitled to any paid sick leave benefits when the sickness or injury is the result of employment by anyone other than the Commission. In cases where an employee is absent from work three (3) consecutive days or more because of illness, the Neenah-Menasha Sewerage Commission Manager may require a physician's certificate explaining the nature of the illness, and the necessity of the employee's being absent from work. In cases of absence of more than two (2) continuous weeks a physician's certificate shall be filed with the Neenah-Menasha Sewerage Commission before a payment is made against sick leave allowance.

If an employee is absent by reason of on-duty accident for which he is entitled to receive workmens compensation, he shall receive only sick leave payments equal to the difference between his salary and the workmens compensation payments. Such differential payments shall be charged against his sick leave. The Commission may deny payment of sick leave benefits if the absence is the result of failure to observe a safety rule.
