# RESOLUTION 81-1

A RESOLUTION ESTABLISHING 1981 SALARIES AND OTHER BENEFITS FOR CERTAIN ENUMERATED SALARIED EMPLOYEES

BE IT RESOLVED by the Neenah-Menasha Sewerage Commission as follows:

Section 1. <u>SALARIES</u>: The annual salaries of the following Commission positions are hereby established for the calendar year 1981.

Superintendent	\$ 24,819
Office Manager	\$ 19,664
Foreman*	\$ 20,863
Chief Chemist	\$ 21,102
Chemist	<b>\$ 18,133</b>
Secretary	\$ 10,911

January 13, 1981 cont...

As used throughout this resolution, the term "salaried employees" shall mean the above designated positions. \* Foreman in charge of safety program shall receive a \$120 per year add-on to his base salary.

Section 2. <u>WISCONSIN RETIREMENT AND LIFE INSURANCE</u>: The Commission shall pay the full cost of both the employer and employee contributions to the Wisconsin Retirement Fund and the full cost of the life insurance policy premiums to each of the salaried employees under the present Life Insurance Program, including the 50% face value after age 65 option.

Section 3. <u>HEALTH INSURANCE</u>: The Commission shall pay the full cost of the Health Insurance program premiums for the salaried employees and their dependents.

Section 4. <u>VACATION</u>: All salaried employees, except the Manager, who have completed one (1) year of service shall be entitled to vacation as shown below:

One (1) year of more of service 5 days of paid vacation Two (2) years or more of service 10 days of paid vacation Eight (8) years or more of service 15 days of paid vacation Thirteen (13) years of service 20 days of paid vacation Sixteen (16) years of service 21 days of paid vacation Seventeen (17) years of service 22 days of paid vacation Eighteen (18) years of service 23 days of paid vacation Nineteen (19) years of service 24 days of paid vacation Twenty (20) years of more of service 25 days of paid vacation Thirty (30) years or more of service 30 days of paid vacation

The Manager shall be entitled to three weeks of paid vacation.

All salaried employees shall be paid the equivalent of one (1) week of their salary for each 5 days of vacation to which they are entitled. A salaried employee will become entitled to his first week of vacation upon completing his first twelve (12) months of employment. The first week of vacation to which the salaried employee is entitled shall be following the first anniversary date of hire, and the succeeding December 31st. Thereafter, salaried employees may schedule weeks of vacation, for which they are eligible anytime

January 13, 1981 cont...

Section 6. <u>HOLIDAY VACATION</u>: Except for emergency plant operation, salaried employees shall not be required to work on the following holidays: Easter Sunday, Memorial Day, Independence Day, Iabor Day, Thanksgiving, the day before Christmas, Christmas Day, the day before New Year's Day and New Year's Day. One additional paid holiday, known as a "floating holiday" shall be allowed salaried employees each year. This holiday may be taken at any time during the year, subject to Management approval of scheduling.

If a holiday shall fall within any vacation period, an additional day of paid vacation shall be given.

# Section 7. SICK LEAVE:

- 1) <u>Definition</u>: Paid sick leave shall be granted for personal illness or injury to the employee alone.
- 2) <u>Eligibility</u>: All regular full-time employees will begin to accumulate sick leave as of the date of hire with the use of sick leave not allowed until completion of the probationary period.
- 3) Accumulation: Sick leave shall accumulate and be paid at the rate of one day (8 hours of straight time) per month to a maximum of 120 days overall. There shall be no fractional days earned for fractional months of service. Paid sick leave shall be at the rate of 100% of the employee's wage rate as stated in the Wage Rate Schedule included in the Union Agreement.
- 4) Retirement Pay of Unused Sick Leave: Upon retirement, per Wisconsin Retirement Fund, each salaried employee shall receive cash payment for 50% of their unused sick leave not to exceed 50% of 120 days or 60 days total, at 8 hours per day, based on their straight time hourly rate of pay. Hourly rate of pay shall be determined by dividing the annual salary by 2080 hours. If termination is by death, no death benefit shall be paid to beneficiaries under this clause.
- 5) <u>Usage</u>: No employee shall be entitled to any paid sick leave benefits when the sickness or injury is the result of employment by anyone other than the Commission.

The Commission may require a Doctor's Certificate to confirm the necessity of anyemployee's being away from work.

If an employee is absent by reason of an on-duty accident for which he is entitled to receive Workman's Compensation, he shall receive his Workman's Compensation check, plus an amount of sick leave which would bring his total salary to 100% of his normal salary. Such differential payments of sick leave shall be charged against his accumulated sick leave.

Section 8. <u>FUNERAL LEAVE</u>: After one (1) year of continuous service the salaried employee shall be entitled to a maximum of three (3) days absence with pay, due to the death of a member of the salaried employee's immediate family.

Immediate family shall be defined as follows: Spouse, parents, grandparents, children, grandchildren, brother or sister of the employee, or the natural mother or father of the employee's spouse.

Section 9: Foremen shall receive a consideration for successful Wisconsin State Certification as a Wastewater Treatment Plant Operator according to the following supplemental pay schedule:

2 \$10/month
3 \$15/month
4 \$25/month

Manager Windau discussed resubmittal of the Step 2 application for EPA or Wisconsin Fund money using Step 1 modifications as part of the Step 2 cost. He reported that there may be federal money already set aside from when the 1979 application was submitted (\$1,760,910) of which we may be eligible to receive 75% but no more than that. If the NMSC would be eligible for Wisconsin Fund money rather than federal funds, they would be eligible to receive 75% of whatever the new cost of Step 2 project would be. Under the Wisconsin Fund program, the NMSC must be prepared

December 1, 1981 cont...

to pay the total Step 2 cost with later reimbursement.

Attorney Goggin stated that although federal money is said to be available, we have no formal statement as to that fact. Manager Windau is to attempt to get a formal statement of availability of federal funds for the NMSC's Step 2 work.

Jerry Brask (CTA) stated that Step 2 would include provision for reviewing and modifying the Step 1 facility plan. The consultant would review the design parameters and prepare a "memorandum of design." The NMSC would review and approve the proposed design before being submitted to the DNR. The consultant will revise the Step 2 cost estimate but it will be based on the existing (1977) facility plan. This cost estimate will be submitted to Manager Windau as soon as possible for inclusion in the Step 2 application. Manager Windau will endeavor to complete the Step 2 application by the end of January, 1982.

Attorney Goggin reported that the ordinance-contract has been signed by the Cities of Neenah and Menasha. The urgency of signing will be made known to the Towns of Harrison and Neenah. Attorney Goggin will meet with Attorney Snyder (Town of Neenah) before the year's end.

Alderman Knaack (Neenah) and Alderman Carpenter (Neenah) entered the meeting.

Dominick DeRienzo and Jerry Brask (CTA) presented their "Invluent Facilities Study" using three alternatives to construct metering/sampling stations and headwork.

Alternate 1: Sewage flow from each of the two cities flows to the inlet manhole east of the treatment plant prior to entering the plant. Sewerage from Neenah is conveyed by a 36" sewer and from Menasha by a 42" pipe to the treatment plant inlet manhole. Under this alternative, it is proposed to install flumes to measure flows in the 36" line from Neenah and the 42" line from Menasha.

The installation of the flume on the 42" line will require construction of a chamber between the junction manhole and the treatment plant inlet manhole. A sampler, sample pump and suction line will be installed and flows from the City of Menasha will be measured and recorded inside the existing operations building.

The installation of the flume on the Neenah line will require construction of a flume chamber also. It is recommended that the 36" Neenah line be disconnected from the inlet manhole and reconnected downstream. This will require construction of two manholes, one at the point of redirection of the flow and the second at the point of reintroduction to the treatment plant sewer. A sampler, sample pump and suction line will also be installed. Estimated project costs - \$101,000.

Alternate 2: This alterbate would include the same modifications described in Alternate 1. In addition, an expanded interim lift station will be constructed at the present termination point of the 60" Neenah interceptor. The 36" Neenah interceptor will be cross-connected to the 60" line and sewage flow will be pumped into a new manhole. The lift station would consist of four submersible pumps. Estimated project costs - \$430,000.

Alternate 3: This alternative considers construction of the influent and pretreatment facilities as recommended in the December, 1977 report. The recommendation included construction of a new raw wastewater pump station, individual metering and sampling facilities on influent lines from each of the two cities, bar screens and grit tanks. Estimated project costs - \$1,952,000.

The first alternative could be designed, constructed and operational with a period of 6 months. It would not be grant eligible.

The second alternative would require an estimated period of 9 to 12 months to be designed and constructed. It would not be grant eligible.

The third alternative would require an estimated 1-1/2 to 2 years minimum for design, bidding and construction. There is a possibility this could be done faster. Parts of this would be grant eligible.

Manager Windau was authorized to question DNR regarding the possibility of proceeding with the third alternative on a parallel fast-track with grants, as opposed to following the typical Step 2/Step 3 grant program. It was suggested that an emergency health hazard due to Neenah-s dry weather by-passing could be a rationale for rapidly proceeding with this part of the plant remodeling. It was also suggested by Superintendent Schuelke that alternatives 1 and 2 could produce wet weather flows at the treatment plant which the existing pumps could not handle, necessitating closure of the headworks gate. This problem would not occur in alternative 3 since new pumps could be sized to handle worst case flow volumes.

The Capital Projects Budget for 1982 was tabled for discussion at the Budget Meeting scheduled for December 8, 1981.
